## **Comments:**

I arrived, unannounced, shortly after the children had signed in. Rehearsals were under way, so I waited at the side of the room. I was very pleased to have been challenged by one of the chaperones as to who I was and why I was there. I spoke to each chaperone, checked they each had their licence card visible, and ticked them off my list. All chaperones I had been advised would be present, were. In addition, Shelley and Ruby (teacher) were present.

It became apparent, almost from the moment I arrived, that arrangements for performers at the May Fayre were very chaotic. Shelley made me aware of the issue she had with the stage and informed me she had spoken to the organizer to register her concern. Whilst some of the staples were removed, little could be done about the carpeting issue before the children performed.

The other issue of concern was several groups being assigned to the same rehearsal room. While Steppin Out were in the middle of their rehearsal, an adult choir of 50+ members entered the room so they could rehearse their performance. Shelley immediately took action to move her children to the far end of the room and quickly created a physical barrier using chairs to separate her children from the adults. She also used this break in rehearsals to encourage her performers to use the toilets if they needed to. Many did, and the chaperones managed this very well.

Whilst this was happening another chaperone went outside to check the route the children would be taking to get to the stage. He raised a concern that only part of the route was protected by barriers, meaning the children would have to negotiate their way through members of the public. Shelley therefore organized her children to walk in pairs with chaperones at the front, back and sides of the children as they filed out of the Town Hall. Once at the stage area, the children were asked to congregate in a tight group under a tree, and the chaperones surrounded them until they were called on stage.

Despite all these concerns, Shelly remained calm and positive, encouraging her children, and praising them for their behaviour. I was re-assured that Shelley had her children's wellbeing and safety very much at the front of her mind and felt she managed some very difficult circumstances quickly and effectively.
